**USE OF QUAYS**

**CONDITIONS**

1. All craft are required to berth as directed by the Harbour Master or Camber Management Agent.
2. It is a byelaw of the Commercial Docks that no craft is left unattended without the prior approval of the Harbour Master or Camber Management Agent.
3. Should an unattended craft require to be moved, the Harbour Master will give the necessary instruction, the cost of such a move to be borne by the owner of the craft.
4. Priority of use of berths is for commercial craft. Allocation to private craft will be on a day-to-day basis only.
5. Portsmouth City Council and the Camber Management Agent accept no responsibility arising from loss or damage to any craft or its contents.

6. Change of ownership of the craft during a stay must be communicated to the Camber Management Agent on the day it occurs by the original owner. The new owner to be instructed to report to the Camber Management Agent in order to complete an application form. Failure to do so may make the original owners liable for ongoing costs.

  - i) Arrangements are to be made for payment direct to the Camber Management Agent office weekly.
  - ii) Casual visitors must settle accounts prior to leaving the Port.
8. Any items of gear left on the quayside will be charged at current Quay Storage fees.
9. All vessels sailing from Portsmouth City Council owned quays carrying fare paying passengers must be licensed by Portsmouth City Council under the Public Health Act, or licensed by the MCA.
10. The Portsmouth City Council shall have the right to exercise a general lien upon the vessel and/or her gear or equipment whilst using the Council owned quays until such time as any monies payable to the Portsmouth City Council under this agreement shall be paid.
11. In the event of payment remaining outstanding in excess of 28 days the City Council may levy a distress on this craft. The craft may ultimately be sold to recover costs.
12. Regular users of the Camber will be required to renew applications for the use of the Quay annually on each subsequent March.

#### **BOAT CHARGES FOR NON-COMMERCIAL CRAFT**

Payable on overall length in respect of all such vessels which secure at the Camber Quay and any other recognised berth or which use the old Slipway at the Camber Quay.

**a) Boat Charges for Registered Fishing Vessels**

Up to 11.5 metres	£0.50 Per metre per day (subject to VAT)
Over 11.5 metres & up to 16.5 metres	£0.51 per metre per day (subject to VAT)
Over 16.5 and up to 30 metres	£35.90 per day
Over 30 metres	£41.40 per day

**b) Pleasure Craft, Yacht, Multi Hull and Other Vessels**

0-9 metres long	£12.10 (VAT inclusive) per day
9.01-10 metres long	£13.50 (VAT inclusive) per day
10.01-12 metres long	£16.70 (VAT inclusive) per day
12.01-15 metres long	£17.10 (VAT inclusive) per day
15.01-16.5 metres long	£19.40 (VAT inclusive) per day
Over 16.5 and up to 25 metres	£42.40 (VAT inclusive) per day
Over 25 and up to 35 metres	£62.05 (VAT inclusive) per day
Over 35 and up to 45 metres	£82.80 (VAT inclusive) per day
Over 45 and up to 55 metres	£96.70 (VAT inclusive) per day
Over 55 and up to 65 metres	£113.40 (VAT inclusive) per day
Over 65 metres	£131.50 (VAT inclusive) per day

**c) Short Stay Vessels (Up to 3 hours maximum)**

Vessels less than 8 metres	£4.80 (VAT inclusive)
Vessels 8 metres – up to 16.5	£7.75 (VAT inclusive)
Vessels over 16.5m	£20.10 (VAT inclusive)
